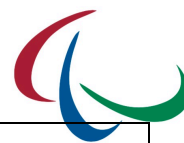

I understand that I have a right to access and correct the Personal Data that the APC holds about me under data protection law by contacting nominating body who will, if required, contact the APC. I acknowledge, however, that such a correction may or may not impact any disciplinary process that has been initiated against me by the APC Legal and Ethics Committee. I also understand that I may withdraw this agreement at any time which will result in me no longer being eligible to stand for this APC Executive Board election.
